





RAISING COMMUNITY AWARENESS

Glenwood Springs

39 educational presentations were given to 208 individuals in Garfield County.

67 community awareness

PANDEMIC SILVER LININGS

It may be hard to believe. But yes, there were quite a few positive initiatives that came to be due to the two-year-long COVID-19 pandemic. Chief among them was our Staff Self Care Policy. ASP Board members recognized that the stressful times were having an impact on the personal and professional lives of our ASP staffers. To mitigate the effects of



COVID-related strain, the board approved 2.5 hours a week (prorated) of regular paid time off for both full and part-time staff working a minimum of 20 hours per week specifically for self care. The policy encourages staff to take time away from work to decompress and engage in restorative activities that enhance wellbeing. ASP promoted the Seven Pillars of Self Care which include emotional, creative, social, physical, intellectual, financial and spiritual touchpoints that nourish a healthy outlook on life. Other pandemic silver linings included:

- Transitioning to a remote work environment, while continuing to provide services for more survivors than ever before;
- A virtual office allowed staff to better balance the demands of work/life schedules;
- Using remote tools helped staff members to communicate more regularly and effectively with one another;
- And, ASP was able to successfully conduct the first entirely virtual Help Line Volunteer Advocate training course.

WELCOMING ALL REMAINS PRIORITY

Our Diversty, Equity and Inclusivity (DEI) work continues. While violent national events brought the need to standardize and develop an anti-oppression statement to the forefront, ASP contracted with a consulting firm specializing in DEI to help craft, educate and train on the topic. In 2021, after several months of consideration, the ASP Board of Directors approved the anti-oppression statement below to better reflect ASP's mission and values.

OUR ANTI-OPPRESSION STATEMENT

Advocate Safehouse Project (ASP) recognizes survivors of domestic and/or sexual violence face discrimination and are victims of systemic oppression. ASP understands domestic violence and sexual assault as examples of how oppression plays out in day-to-day life. Violence, physical or verbal, against people or groups because of their gender, race, religion or sexual orientation is oppression. ASP values equity as an organization and is committed to working towards the common goal of justice for all – where no person or group is oppressed.

EXPERIENCE THAT COUNTS

ASP's six full-time staff members have a combined 59 years of experience. Our three direct service part-timers have 30 years combined. Together that's 89 years of experience working to educate the public and to assist survivors affected by domestic and/or sexual violence.

HIGHLIGHTS

GLENDA MARTINEZ - 2021 GARFIELD COUNTY HUMANITARIAN AWARDS NOMINEE



ASP Bi-lingual Client Advocate, Glenda Martinez, was nominated for the 2021 Garfield County Humanitarian Awards. "I feel very humbled and honored." Glenda said. "Of course, it's wonderful to be recognized but I'm just doing my job. The truth is I want good outcomes for our clients. I'm a romantic at heart and I like happy endings."

Martinez is the first to admit that those happy endings are hard-won and sometimes don't materialize. "I've been doing this for seven plus years and it's a beautiful thing to see a survivor blossom like a flower, but it is a journey." As a bi-lingual client advocate, Martinez explained that Spanish speakers who are new to the country have compounded struggles. "Everything is harder when you don't know the language. My job is to build a relationship with survivors, teach them life skills like how to look for a job, stay safe, navigate the courts and gain support through community resources."

"So many people have lost their way and just don't know how to get help," Martinez said. "We are the ears and eyes to help survivors navigate safe passage to a happier, healthier version of their life and see the opportunities the future holds for them and their children." While no one can guarantee another person a happy ending, Martinez does her best to make them a possibility.
